## Quote Terms & Conditions

1. The prices in this Quote will remain valid for a period of 30 days from the date of issue of this Quote. The pricing may change after this period. No further trade discounts will apply. All prices are GST exclusive.
2. This schedule of materials is prepared for pricing purposes. While some materials may be able to be ordered directly from this schedule, it is the Customer's responsibility to confirm that the materials and quantities ordered are correct and suitable for the purpose. The availability of specialty non-stocked items needs to be confirmed by the supplier at the time of ordering.
3. Where quantities have been estimated, standard industry measures and wastage allowances have been employed. It is the responsibility of the customer to check and confirm all quantities prior to placing the order.
4. Where timber is marked with a call size (e.g. 100 x 25), Woodmart has estimated quantities based on the supplier's standard product sizes. It is the Customer's responsibility to confirm that the materials and quantities ordered are suitable for what is to be constructed. The Customer will be charged for any costs associated with requests for non-standard product sizes.
5. Where quantities have been assessed, it has been done to the best of our ability from the information supplied, for pricing purposes only. It remains the Contractor's responsibility to check the schedule of quantities prior to using for pricing or placing a firm order.
6. The nails and fixings requirements in this schedule may vary depending on the construction method used. Any of these materials are estimated as a guide only.
7. Pole lengths must be checked on site before ordering as ground levels often vary from those shown on the plan.
8. The Quote has been priced competitively based on Woodmart supplying all the materials in this Quote for the project. The pricing may be subject to change if only some of the materials on this Quote are ordered from Woodmart.
9. Where products are scheduled in a particular finished size, we have allowed for the nearest standard size. We have not included for any machining or the like.
10. It is the Customer's responsibility to check material description, quantities, and sizes before purchasing as Woodmart accepts no responsibility for scheduled errors or quantity variations.
11. Where a non-stocked product has been estimated and Woodmart has received an order, then no credits or returns may be accepted unless otherwise agreed. Additionally, returns may incur a 20% restocking fee.
12. Payment is due on the 20<sup>th</sup> of the month following invoice. Cash sales invoices must be paid before delivery.

3. When a CONTRACT has been signed and accepted it is a requirement that plans with the ORIGINAL STAMP on must accompany all production requests.
4. This Quote is based on Woodmart being the Sole Provider of all the included submissions and may become null and void if any particular section of the Quote is not accepted.
5. The materials included in the Quote are material supply only and EXCLUDE any site works or any additional labour or otherwise to achieve a particular end use unless otherwise specified by Woodmart in writing.
6. Timber treatment has been specified to the best of Woodmart's knowledge and in accordance with the plans and specifications provided. Woodmart takes no responsibility for the specification of timber treatment in any documentation provided by the customer. The appropriate timber treatment for products shall be the responsibility of the customer.
7. DELIVERY
  - Cartage to site will be as per Woodmart's standard freight charges and are to kerbside only.
  - Where drivers are requested to deliver on to private property, should there be any resulting damage due to these requests, it will be at the CUSTOMERS LIABILITY AND EXPENSE.
  - If pre-nail frames or trusses or associated materials have to be manufactured outside of the boundaries of a standard size for transportation, a wide load/and or pilot vehicle charged will be passed on to the CUSTOMER.
  - Excessive site turnaround time for whatever reason and /or requests for placement of specific products or components, unless otherwise stated, will incur an additional delivery cost at the CUSTOMERS expense.
  - Deliveries are specific to each and every QUOTE and cannot be transferred for pricing or any other purpose.
